Children in school will get support that is specific to their individual needs. This may be all provided by the class teacher or may involve:

- Other staff in the school
- Staff who will visit the school from the Local Authority central services such as the ASD Outreach Team or Sensory Service (for students with a hearing or visual need)
- Staff who visit from outside agencies such as the Speech and Language therapy (SALT) Service.

	<p>Specified Individual support for your child of, as a guide, 21 hours or more, in school.</p> <p><i>This is provided via an Education, Health and Care Plan (EHCP) or if your child has had this type of support for some time, may be provided by a Statement of Special Educational Needs.</i></p> <p>This means your child will have been identified by the class teacher/Senco as needing a particularly high level of individual and small group teaching (as a guide, more than 21 hours in school), which cannot be provided from the resources already delegated to the school.</p> <p>Usually, if your child requires this high level of support they may also need specialist support in school from a professional outside the school. The school will then meet with you and other professionals involved, and decide if it would be helpful to apply for a statutory assessment, and agree any additional information and evidence that should be included from you, other involved professional and them. • After the school have sent in the request to the Local Authority (with a lot of information about your child, including some from you), they will decide whether they think your child's needs (as described in the paperwork provided), seem complex enough to need a statutory assessment. <p>How will the school let me know if they have any concerns about my child's learning in school?</p>	<ul style="list-style-type: none"> • When a teacher or a parent has raised concerns about your child's progress, and targeted teaching has not met the child's needs, the teacher will raise this with the SENCo. • Schools also have meetings every term between each class teacher and a senior staff member in the school to ensure all children are making good progress. How are the adults in school helped to work with children with an SEND and what training do they have?	<ul style="list-style-type: none"> • The Senco's job is to support the class teacher in planning for children with SEN. • The school has a school development plan, including identified training needs for all staff to improve the teaching and learning of children including those with SEND. This may include whole school training on SEND issues or to support identified groups of learners in school, such as ASD, dyslexia etc. • Whole staff training to disseminate knowledge, strategies and experience, to ensure consistency of the school's approach for children with an SEND. • Individual teachers and support staff attend training courses run by outside agencies that are relevant to the needs of specific children in their class e.g from the ASD Outreach service or medical /health training to support staff in implementing care plans. <p>Training takes place on a regular basis. If you would like to hear about the training which is currently taking place or has taken place by the staff members in the school, please speak to the Head teacher or Senco.</p>

How will we measure the progress of your child in school? How will I know about this?	<ul style="list-style-type: none"> • Your child's progress is continually monitored by his/her class teacher. • His/her progress is reviewed formally every term in reading, writing, numeracy and science as well as progress in other areas, as appropriate, such as attendance, engagement in learning and behaviour.

| | <ul style="list-style-type: none">• If your child is in Year 1 and above, but is not yet at Expected levels (to change to a new assessment system in September), a more sensitive assessment tool is used which shows their level in more detail and will also show smaller but significant steps of progress. The levels are called 'P levels'.• At the end of each key stage (i.e. at the end of year 2 and year 6) all children are required to be formally assessed using Standard Assessment Tests (SATs). This is something the government requires all schools to do and are the results that are published nationally.• Children at SEN Support may have a personal learning plan which will be reviewed with your involvement, every term and the plan for the next term made.• The progress of children with an EHC Plan or Statement of special educational needs is formally reviewed at an Annual Review with all adults involved with the child's education.• The SENCo will also check that your child is making good progress within any individual work and in any group that they take part in.• A range of ways will be used to keep you informed, which may include:<ul style="list-style-type: none">○ Home/school book○ Letters/certificates sent home○ Additional meetings/reviews as required○ Reports○ Parent/Carer evenings |

What support do we have for you as a parent of child with an SEN/and or disabilities?

- We would like you to talk to your child's class teacher regularly so we know what they are doing at home and we can tell you about what we are doing in school. This is to ensure that we are doing similar things to support them both at home and school and can share what is working in both places.
- The Senco (or Head teacher) is available to meet with you to discuss your child's progress or any concerns/worries you may have.
- All information from outside professionals will be discussed with you with the person involved directly, or where this is not possible, in a report. The SENCo may also arrange to meet with you to discuss any new assessments and ideas suggested by outside agencies for your child.
- Homework will be adjusted as needed to your child's individual needs
- A home/school contact book may be used to support communication with you, when this has been agreed to be useful for you and your child.

In addition:

If your child is undergoing statutory assessment you will also be supported by the Children's Services SEN Team. They will ensure that you fully understand the process.

How will we make arrangements to ensure that the social emotional needs of your child are met in school?

- There is a calm, trusting and friendly atmosphere around the school. Pupils are always polite, they respond positively to adults and are considerate of the needs of other pupils. They are kind to each other and voluntarily offer to help those who may be facing difficulties with their learning. They appreciate the diversity within the school community. They work in teams in lessons and during playtimes without a fuss.
- Clear expectations, a consistent timetable and regular routines provide a predictable environment which helps all pupils feel emotionally safe and secure. All staff are committed to supporting and guiding pupils and we have a full-time Learning Mentor, a weekly 1:1 counselling service and the ability to refer pupils for additional specialist support.
- The school has an effective and consistent approach to behaviour expectations linked to our Golden rules and based on our core values of Hard work, Teamwork, Helpfulness, Kindness, Friendship, Respect, Trust and Fairness. We use positive strategies and rewards balanced with clear and proportionate sanctions alongside our anti-bullying policy. While this approach supports most pupils with SEND, some are provided with a specific tailored reward programme.
- One of the key drivers for our school curriculum is -

Social and Emotional well being

We enable children to understand and value, their own and others, social and emotional needs, and to implement this in their day to day lives. Every child at Conway will have access to:

- Social and emotional support from a highly skilled inclusion and mentoring team.
- Develop positive and collaborative relationships with children of different age-groups, genders and ethnicities.
- Take responsibility within the school.
- Nominate themselves for School Councillor, Peer Supporter or Buddy.
- Have their individuality supported, recognised and understood.

	<ul style="list-style-type: none"> • Support charities through fundraising activities. • Personal, Social and Health Education is taught through assemblies, using the guidance of the Government's Social and Emotional Aspects of Learning (SEAL) curriculum. This is also taught in class alongside the assembly theme and may include strategies for sharing such as circle times. • The school has robust systems and procedures for safeguarding and child protection to ensure the well-being of all pupils.

<p>How does our school make special arrangements for looked after Children (LAC) with SEND?</p>	<ul style="list-style-type: none"> • At present there is 1 looked after children on role, who is not on the SEND register. If the occasion arose, we would consult with the virtual school – Head Teacher and SENCo as appropriate for personalised support as required. We also liaise with the allocated social worker, to ensure all agencies are working collaboratively to develop an appropriate support package (PEP/EHCP/Statement) for each child. • We review the child’s needs and progress regularly, for example before entering the school to ensure a smooth transition from their previous setting and then at regular intervals. • We ensure Pupil Premium Plus is being used to effectively enable the child to meet their outcomes <p>http://www.conwayprimaryschool.co.uk/page/?title=Pupil+Premium&pid=15</p> <ul style="list-style-type: none"> • The SENCo ensures that training and policies are supportive of looked after children with SEND • The Designated Governor for SEND and LAC works to ensure provision is enabling LAC with SEND to make good progress.

OR moving on to another class?</p>	<p>We recognise that ‘moving on’ can be difficult for a child with SEN/and or disabilities and take steps to ensure that any transition is as smooth as possible.</p> <ul style="list-style-type: none"> • If your child is moving to another school: <ul style="list-style-type: none"> ○ We will contact the new school’s SENCo and ensure he/she knows about any special arrangements or support that need to be made for your child. ○ We will make sure that all records about your child are passed on as soon as possible. • When moving classes in school: <ul style="list-style-type: none"> ○ Information will be passed on to the new class teacher IN ADVANCE and in most cases, a planning meeting will take place with the new teacher. ○ If your child would be helped by a book to support them understand moving on then it will be made for them. • In Year 6
